### ELDORA INDOOR COURTS BEGINS ITS 23RD SEASON

The 2011-2012 Indoor Season at the Putt Mossman Arena in Eldora began at 10:00 a.m. on November 5, 2012. Samantha Reinertson of Eldora was invited by Bob Walters and the Hardin County Fair Board to throw the first pitch of the season. Thirty-three players began pitching on nine courts with eighteen newly built boxes, each painted red, white or blue. There were seven class champions, with Larry Purcell winning the championship class pitching 67.50%.

### PRESIDENT'S MESSAGE

As many of you know, my wife and I spend our winters in Arizona pitching horseshoes among other things. In this message I would like to show you what horseshoe pitching is like in Arizona.

We pitch in a league every Tuesday morning and travel every other week to a different RV Park. We pitch three games of singles (40 shoe count all) and three games of doubles with wins and losses totaled up for winners in singles and doubles. A tournament follows at the end of the year and then we have a banquet with food catered in to our home park.

I had the honor of pitching horseshoes one evening at our friends' home where we had a celebration serving

cake, ice cream and finger food. This celebration was in honor of the Marine Corps founding 236 years ago. Dave (Marine Corps Veteran) read a letter from the commander, then cut the cake with two sabers. Very emotional for him recalling his father's service in the Marines in WWII.

We also had another tournament at Dave & Trisha's house as a fund raiser prior to Christmas. All the money that was collected went to purchase gifts and have them delivered to the disabled American Vets. The first year we raised \$1700 and this year we raised \$3100 for a very good cause.

IHHPA HALL OF FAME  
DANNY SEASE

Danny Sease started his pitching career in 1972 at the Birdland Courts in Des Moines. In 1973, he was elected Secretary-Treasurer of IHHPA and served six years. He and his wife, Bobbie, also served as statistician and newsletter editors.

In 1973, the ringer percentage system that was being used in Oregon was introduced to Iowa, and from then on a player's percentage was established by tournament play. There would be no more qualifying on the day of the tournament.

In 1974, Danny became Superintendent of Horseshoe Pitching at the Iowa State Fair. He served one year then became assistant to Marion Lange until 1979. Also in 1974 Danny and IHHPA Member Keith Baker started the Greater Des Moines Horseshoe League at Birdland Park. That same year the NHPA Secretary-Treasurer, Walter Ray Williams, Sr., was traveling through Iowa on their way to the World Tournament on the East Coast. Danny arranged an exhibition at Birdland Park between World Junior Champion, Walter Ray Williams, Jr., and the Iowa State Junior Champion, Jerry Sease. The Williams Family camped in his backyard and talk began of a World Tournament in Des Moines. (Continued next page)

### IHHPA Hall of Fame/Danny Sease cont'd

In 1977, after talking to the Des Moines Chamber of Commerce, Danny went to the World Tournament in Greenville, Ohio, met with the NHPA and began talking about Des Moines. In 1978, the World Tournament was offered to Des Moines. Danny became Co-Chairperson of the 1978 World Tournament and received the NHPA Achievement Award. The World Tournament was held at the Iowa State Fairgrounds and Birdland Park. Two hundred players from Iowa entered the tournament.

In 1979, Danny helped found the Central Iowa Traveling League, which is still recognized as one of the longest running NHPA sanctioned leagues in the country. Danny continues to play every year in the CITL and has been recognized by the league as Player of the Year for his organization efforts.

In 1981 Danny was inducted into the IHHPA Hall of Fame. Danny has served a total of ten years as Secretary Treasurer of the IHHPA, including statistician, and four years as 2nd Vice President, for a total of 14 years of service as an officer of the IHHPA. In 1988 he became Co-Director of the Hawkeye NHPA Regional Tournament at the Iowa State Fairgrounds. In 1990, he was awarded the Distinguished Service at the IHHPA Annual Meeting for service to the Association. In 2002, he again became Superintendent of the Iowa State Fair Horseshoe events, and has taken a photo of every person awarded a ribbon at the Iowa State Fair for the past nine years. In 2002 Danny received the President's Award for Tournament Director of the Year.

Danny was a letter carrier for 37 years and received a 50-year Gold Pin for membership in the Union. He has played horseshoes over the last 39 years and says he has enjoyed the friends in horseshoes he has made in Des Moines, in Iowa and across the USA.

COURT SIDE RECIPES

Nancy Hatch, wife of IHPA member Steve Hatch of Knoxville, sent these bars to one of the tournaments in Eldora. Several members asked her to share her recipe.

APPLE ALMOND BARS

- 2 c. flour
1/2 c. sugar
1/2 tsp. baking powder
1/2 tsp. salt
1 c. butter
2/3 c. sliced almonds
2 egg yolks, slightly beaten

- 3/4 c. sugar
1/4 c. flour
1 tsp. ground cinnamon
1/4 tsp. ground nutmeg
4 medium cooking apples

In large bowl, stir together 2 c. flour, 1/2 c. sugar, baking powder and salt. Cut in butter until pieces are size of peas. Stir in almonds and egg yolks with fork. Press half of mixture in an ungreased 13x9 pan (about 2 cups). Set aside remainder of mixture.

In another large bowl, stir together the 3/4 c. sugar, 1/4 c. flour, cinnamon and nutmeg. Add apples and toss to coat. Arrange evenly over mixture in 13x9 pan. Sprinkle remaining crumb mixture over apple mixture.

Bake in 350 degree oven about 35 minutes or until golden brown. Cool in pan. Drizzle with icing. Let stand until set. Cut into bars. Makes about 24.

Icing: In small bowl, stir together 3/4 c. powdered sugar, 1 Tbs milk and 1/4 tsp almond extract until smooth. I added a little more milk, but it should not be too thin.

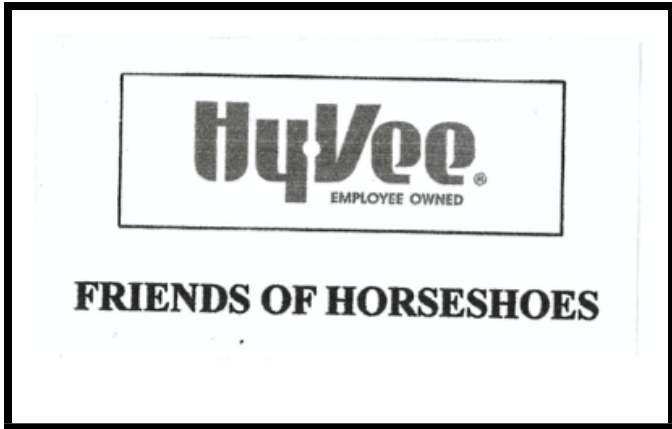
