WORLD TOURNAMENT INFORMATION  
'CALLING THE SCORE'

*A member suggested that I share a few tips about calling the score at the World Tournament. As you know, electronic scoring will be used on all courts, except the playoff courts. As you also know, horseshoe pitchers call the score differently-in different parts of the country. HSScorekeeper, the software developed by Kurt Whaley, has the NHHPA-number one recommended scoring calls on the operator buttons. Here is the list of calls as they appear on the scorekeeper's screen:*

No Score	1 ringer 3	2 dead	4 dead
1 point	1 ringer 4	2 dead 1	
2 points	2 ringers 6	2 dead 3	

*Try to use these score calls at the World Tournament. If you call "3 on 3" you may get a deer-in-the-headlight stare from the scorekeeper. Try to get into the habit of calling these scores and you will have a much better World Tournament experience. Good luck!*

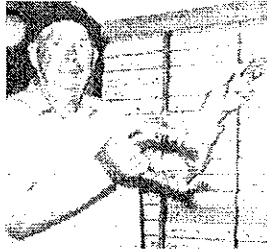

**IHHPA HALL OF FAME  
JOHN PAXTON**



John Paxton of Ottumwa, Iowa, began his horseshoe career in the 1920's. He was a farmer pitching in the What Cheer area. Later he began competing in tournaments with two all-time greats, Frank Lundin and Frank Jackson, both former World champions.

In 1939 after some controversy with the Iowa State Fair, The State championship, also known at that time as the Midwest National, was held at Ellis Park in Cedar Rapids. John won that championship.

John qualified for Men's Championship Class in nine World Tournaments from 1940 through 1959, winning 111 games averaging 66.6% ringers. His best finish was in 1941 when he placed 12th and pitched 68.3%. He accomplished that same average in 1953 but placed 20th with a 17-18 record. John won five consecutive Senior Men's World Championships, beginning in 1966 through 1970 which remains a record. His 10-year record was 62-15, averaging 69.4%.

John was elected as a Charter Member of the IHHPA in 1977. He was inducted into the NHPA in 1982. John Paxton passed away August 5, 1983.

*John was, in my opinion, one of the truly great horseshoe players that I have known. John's record in our great sport certainly speaks for itself. John participated in and placed high in practically all the State Champions where I played. I knew that I was in for a 'barn burner' when it was my turn to play John!*

*John threw a very high shoe, one and a quarter. I did not dare to watch John's shoe. I would see airplanes, dark clouds, high soaring birds, you name it! I believe that anyone interested in horseshoe playing, particularly in the State of Iowa, should do a little research and observe the record of Mr. Paxton - - it is incredible! In closing I will say that John Paxton was a fine player, a credit to the sport and truly, a good friend.*
